Retirees do not have to take any action at this time. The EmblemHealth / Empire BlueCross BlueShield Senior Care plan will remain premium-free until the new Medicare Advantage plan is implemented. Once the Court announces an implementation date, we will notify retirees of the period of time they will have to opt out of the Medicare Advantage plan. As soon as we have an approved implementation date from the Court, we will advise retirees.

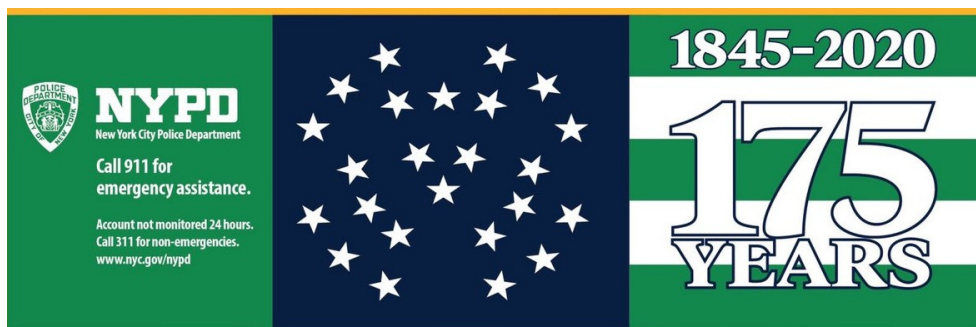
