The deadline for filing the Notice of Participation with the New York Police Pension Fund is September 11, 2022. This is the last time the deadline will be extended. Make sure you have filed the Notice of Participation to be eligible for disability benefits should you become ill from your 9/11 rescue and recovery work. The Notice of Participation Form can be found on the NYPD Police Pension Fund website. I also have a copy if you should need it. If you believe you already filed, but are not sure, the Police Pension Fund has listed all the Tax ID numbers of those whose paperwork they've already received under "WTC Information" on the left side of the home page. https://www1.nyc.gov/html/nycppf/html/wtc_information/wtc_information.shtml

First, click on "WTC Information" and check the pdf file to see if your number is listed. If it is, then you do not have to re-file. However, if your number does not appear, you must file the form (even if you currently have no symptoms of illness) by September 11, 2022 to be eligible in the future in case of illness and/or death.

Some update on the Medicare Advantage Plan from the DEA website. On December 14, 2021, Judge Lyle Frank issued a decision on the NYC Medicare Advantage Plus Plan lawsuit. As you know, the previously planned effective date had been January 1, 2022. However, Judge Frank decided to allow the program to move forward with a revised start date of April 1, 2022. The new program implementation date will be effective provided Judge Frank is satisfied that the appropriate outreach has been made to physicians and, in turn, communicated to retirees.

Furthermore, the Court agreed with the Municipal Labor Committee (MLC) and ordered that retiree be held harmless with respect to deductibles. Any payment towards deductibles that NYC retirees make before the new plan becomes effective on April 1, 2022, will count towards the annual deductible in the new NYC Medicare Advantage Plus Plan. Also, any plan premiums for plans other than the new NYC Medicare Advantage Plus Plan will not go into effect until April 1, 2022 and will not be deducted from members' pension checks until that date. Member ID card mailings will be adjusted to correspond with the new April 1, 2022, date as well. Lastly, the Court ruling will permit flexibility in retirees' decision-making during the transfer, and there will be a continuing opt-out and opt-in period until, at least, June 30, 2022.

In today's Daily News: Elderly spouses of cops, firefighters and other New York City workers who died in the line of duty are being told they will have to start paying for health insurance if they opt out of a new Medicare plan the city is forcing on them and thousands of municipal retirees, the Daily News has learned.

After the 9/11 attacks, state legislators passed a law allowing line-of-duty spouses — widows or widowers of uniformed city employees who died on the job — to remain on their late loved ones' health insurance for life, free of charge. Now, survivors age 65 and older will be responsible for a \$191 monthly premium starting in April if they decide to stay on their current coverage instead of being automatically enrolled in the new Medicare plan, emails from ex-Mayor de Blasio's administration reveal.

"Unfortunately not," a representative of de Blasio's Office of Labor Relations wrote in a Dec. 23 email to a widow who asked if she would still have free insurance if she kept her current plan. "When the premium changes in April, the new cost will be \$191 for all members with no RX coverage

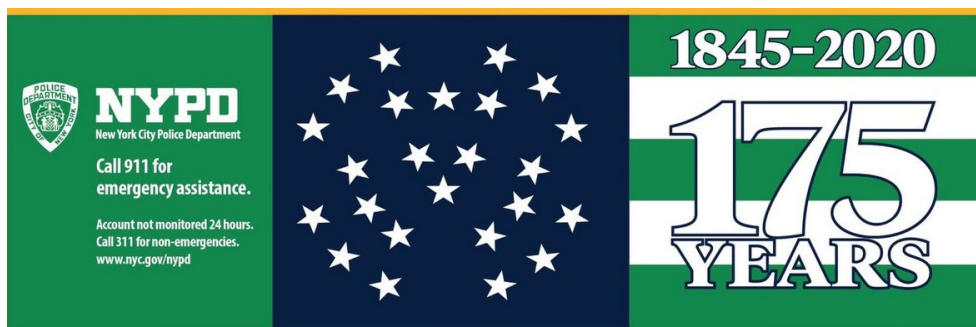




