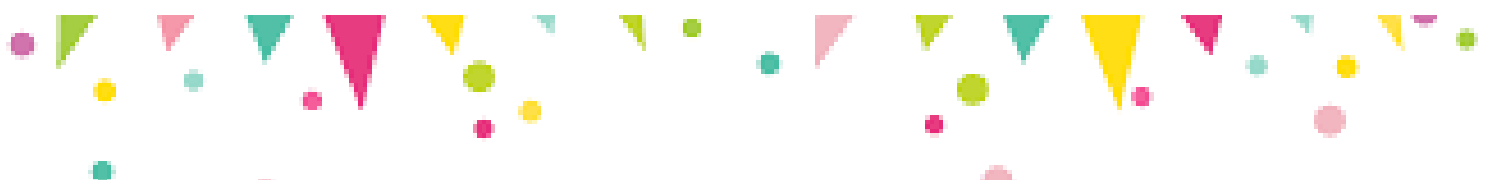

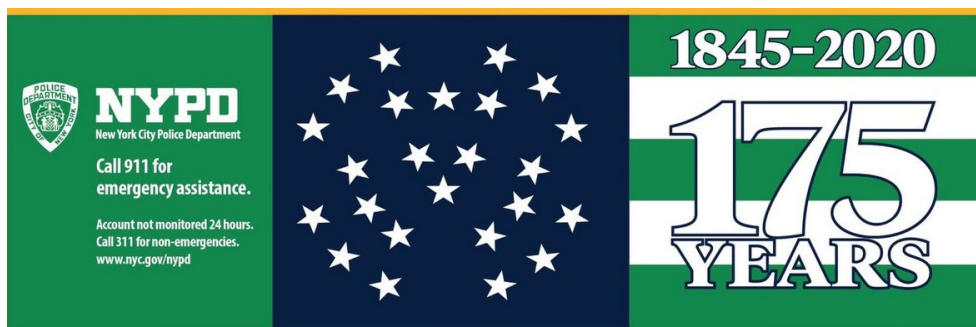

Dates are pretty much open in September.

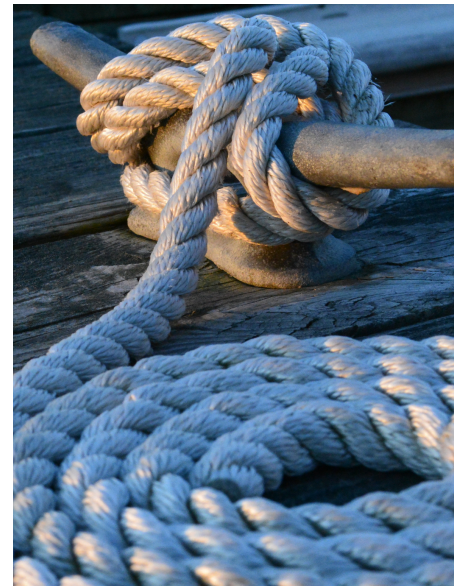
Cruise leaves from the Stuart -Marriott Hotel dock & cruises to Jupiter
