Greetings to my Brothers/ Sisters in Blue,

Our June meeting was very well attended, with a packed house of 51 members.

Our meeting was dedicated only to Michelle Cintron who is an Aetna representative. Michelle was knowledgeable and answered many questions.

Regarding the Medicare Advantage Plan, a Temporary Restraining Order was issued by Judge Lyle E. Frank today, July 7th, due to the ongoing lawsuit brought about by a city retiree group. Due to this court ruling, everything is now on hold. Retirees do not need to do anything further at this time. As of now, you will remain in your current Medicare Plan. Further, all optouts are paused.

There is no need to opt out by July 10. Even if you already opted out, you do not need to do anything at this time. No waiver of City health benefits, enrollment into the Aetna Medicare Advantage PPO Plan or adding the prescription drug rider that has been submitted on the Retiree Special Enrollment/Waiver Form will be processed at this time.

All current health plans remain in effect. Medicare-eligible retirees' health coverage will remain unchanged until a further ruling in the case. We will continue to update you on developments in this case as information becomes available.

The National Fraternal Order of Police regrets to report that as of midnight on 29 June, there have been **194** officers shot in the line of duty so far in 2023 (+**30%** from 2021 YTD; +**6%** from 2020 YTD). Of those officers shot, **25** of them were killed by gunfire (-**14%** from 2021 YTD; -**22%** from 2020 YTD).


There have been **57** ambush-style attacks on law enforcement officers this year. These ambush-style attacks have resulted in **66** officers shot, **11** of whom were killed by gunfire.

The number of ambush-style attacks listed does not include the countless incidents where an officer was shot at but not struck by gunfire during an ambush-style attack.


