Anthony Marone of the Manasota 10-13 is our information guru. Here is some information from Tony regarding the Medicare Advantage and recent issues about Emblem Health GHI.

"There has been talk about an effort to implement cost saving measures to the Medicare Advantage for those members over 65 and disabled. NYC is reviewing bids from Medicare Advantage Providers. What this means is the Medicare will continue being primary insurance, but Emblem Health GHI will no longer provide supplemental coverage. Supplemental coverage will be provided by the group sponsored Medicare Advantage plan. If your doctor accepts Medicare, he/she will HAVE to accept the Medicare Advantage plan. Supposedly, there will be no reductions in benefits, such as transportation assistance to appointments, meals after in-patient stays, fitness programs and nurse support. This is supposed to take effect 7/1/21, but we shall see.

For those who are not on Medicare in the recent past Emblem Health GHI had closed panels to out of state doctors. After many of you and many other retirees held a letter writing campaign and with the help from Retired Sgt. Bill McMahan and key members of the PBA, DEA and the SBA Emblem was forced to re-open the panels. Since Mid-March, at least 64 new doctors have been added to the panels. I do not know what their specialties are. In addition, Emblem is being audited because their website is misleading and inaccurate."
