Greetings to my Brothers/ Sisters in Blue.

I am back from a month's long vacation from Georgia. My family and I were out in the middle of nowhere. No internet access at all in the rural areas. It was a nice break. Thank You Vice President Steve Confino for running last month's meeting. I heard it was a great meeting.

It is time for the 2023 St Patrick's Day Parade. The parade will be on March 18th at 11:00am at the Mid Florida Event Center @ 9221 Southeast Event Center Place, Port St. Lucie, FL 34952. We are marching again this year. All members who plan on attending need to be at the Mid Florida Event Center no later than 10 am. I will be there at 9am. The parking lot is on the north side of the old Bealls outlet store. The parade will begin at 11:00am. I will provide a map to those who have not participated before to show exactly where we will meet up. There is no throwing candy or anything towards the crowd. Please wear your NYPD apparel, the crowd loves it. We will not have our booth "tent" sent up for recruitment. The city has changed some rules and now requires all to have insurance to set up a booth. So, we will sit this out.

On March 09, 2023, the Municipal Labor Committee, dominated by the United Federation of Teachers (UFT) and District Council 37 (DC 37), voted to dramatically change how health benefits are provided to our most senior members. New York City's public sector union bosses signed off Thursday on a highly controversial plan to make a cost-cutting, partially privatized version of Medicare the only health insurance option available for the municipal government's retired workforce.

The stamp of approval from the Municipal Labor Committee, which is made up of reps for all local public sector unions, clears the way for Mayor Adams' administration to eliminate traditional Medicare as a choice for the city's 250,000 retired workers.

In its place, the administration will offer a Medicare Advantage Plan managed by private health insurance giant Aetna as the only premium-free coverage available for municipal retirees. The administration has for months maintained the Advantage plan will provide retirees with adequate coverage while saving the city hundreds of millions of dollars per year thanks to increased federal subsidies — and Municipal Labor Committee leaders have sided with that argument.
