Florida lawmakers voted to "lock the clock" in 2018 to keep daylight saving time permanent but congressional approval is required and that hasn't happened yet.

The number of police officers shot in the US so far this year has jumped by more than 10% compared to 2020 — more than one-third of them in ambush-style attacks, the nation's largest police support group said Wednesday. As of Monday, a total of 281 law enforcement officers had been shot in 2022, at least 55 of them fatally, the National Fraternal Order of Police said in a new report released Wednesday. That included 104 cops who were shot in 71 separate ambush attacks — with 27 of those officers killed, the report said. <https://national.fop.net/report-shot-killed-20221102#page=1>

A New York Supreme Court judge last week ruled that the vaccine mandates issued by the New York City Health Commissioner are unconstitutional and violate the separation of powers. The ruling permits city employees to return to work effective immediately and orders backpay. New York City Mayor Eric Adams is ignoring the state Supreme Court's order to reinstate unvaccinated officers.


