New York City will not enforce the COVID-19 vaccine mandate for the NYPD following a judge's surprise ruling late last week that the requirement was unlawful. The about-face means unvaccinated NYPD cops who have been denied a religious or health exemption will remain on the job as the city appeals the latest court ruling, according to the Police Benevolent Association. Lawyers for the Big Apple had told the PBA on Friday that the city would continue to enforce the mandate despite the ruling from Manhattan Supreme Court Justice Lyle Frank. The change of plan from the city came Tuesday morning after the PBA threatened to try to get the court to hold the city's Corporation Counsel in contempt. The ruling was one of two recent blows to the city's mandate after numerous legal challenges since it was enacted in October 2021 and is expected to spark additional challenges.

The NYPD Detectives' Endowment Association has come out against New York Attorney General Letitia James' reelection bid.
